## **Change Description and Rationale:**

In an effort to continually improve and standardize our business systems, Saint-Gobain Life Sciences will be updating the Global CoC and CoA templates with the following changes.

1) The Biocompatibility claim statement is changed to become optional when it is applicable to the product being released or required by the end user.

This statement is not required for all products supplied by Saint-Gobain Life Sciences therefore the change is to make it be an optional field. This will only be visible for products supplied by Saint-Gobain Life Sciences where it is a product defined requirement and currently documented on the certificate.

2) The Biocompatibility claim statement content has changed to align with the product claim change associated with change notification CO-03373.

The Bioprocess Solutions business has approved a product claim change, CO-03373, specific to the language used to support Biocompatibility. A separate change notification has been supplied to customers that are impacted by the product claim change for additional justification and rationale. This will only be visible for products supplied by Saint-Gobain Life Sciences where it is a requirement.

- 3) Minor formatting content to add a "," where required throughout the document. The formatting change does not impact any content within the certificate.
- 4) Removal of the statement under the signature "The Plant Quality Manager (Insert Name) has authorized the above individual to sign this certification for product release" and add "Authorized" in front of the Quality Representative releasing the product.

This modification has been made to simplify the requirement to assure authorized quality representatives are approving the certificates for product release.

The change to the global Saint-Gobain Life Sciences Certificate of Conformity (CoC) and Certificate of Analysis (CoA) templates applies to all Saint-Gobain Life Sciences sites where the global CoC and CoA have been implemented. Those sites include:
